



GCSG Global Pharma/Biotech Pass

Terms & Conditions

1. Global Pass participation is limited to Pharma/Biotech companies only. A Pharma/Biotech company is a company that researches, develops and manufactures drugs and is listed as the sponsor for associated clinical trials.
2. Purchase of a Global Pharma/Biotech Pass does not guarantee hotel room availability.
3. There will be no refunds granted once purchase of the Global Pharma/Biotech Pass is completed.
4. Each Pharma/Biotech company can purchase up to five (5) Global Pharma/Biotech Passes. The same conditions apply to all of the Global Pharma/Biotech Passes. Note, individual conference registration attendee limits for an individual company are inclusive of registrations attained using a Global Pharma/Biotech Pass.
5. The Global Pharma/Biotech Pass entitles the purchasing company to 1 registration at each of the next 3 consecutive GCSG conferences – 1 in each region (US, Europe and Asia Pacific). The Global Pharma/Biotech Pass cannot be used to secure two registrations at one conference.
6. The Global Pharma/Biotech Pass can be purchased at any time. After purchase, registration using that Global Pharma/Biotech Pass will be limited to 1 attendee at each of the next 3 sequential GCSG conferences (e.g. purchasing the Global Pharma/Biotech Pass in May 2026 will enable one registration for the 2026 EKF in October, the 2027 Asia Pacific Conference in March and the 2027 US Conference in April).
7. To utilize the Global Pharma/Biotech Pass for a particular conference, the Global Pharma/Biotech Pass must be purchased no less than 12 weeks prior to Day 1* of that conference (e.g. to use the Global Pharma/Biotech Pass for the 2026 US conference, the Global Pharma/Biotech Pass must be purchased by Feb 01, 2026 as Day 1 of the conference falls on April 26, 2026).
8. The Global Pharma/Biotech Pass cannot be transferred to any future conference beyond the three sequential conferences following the purchase of the pass (within the timing outlined in #7 above). For example, if the Global Pharma/Biotech Pass is purchased at least 12 weeks prior to the 2026 Asia Pacific Conference, it must be used



for the 2026 Asia Pacific Conference, the 2026 US Conference and the 2026 EKF. If the company is unable to send a delegate to the 2026 EKF, they cannot transfer the registration to any other conference.

9. When using the Global Pharma/Biotech Pass, the conference attendee does not have to be the same person at each regional conference but should be an employee of the purchasing company.
10. The Global Pharma/Biotech Pass will be effective immediately if purchased at least 12 weeks prior to Day 1* of the desired conference. If purchased less than 12 weeks prior to Day 1 of the desired conference, registration for the desired conference using the Global Pharma/Biotech Pass will be at the discretion of GCSG.
11. Purchase of a Global Pharma/Biotech Pass does NOT automatically register an attendee from the purchasing company at any GCSG conference. Purchase of a Global Pharma/Biotech Pass simply holds a space for an attendee. Registration must still be completed by the attendee (or designated booking contact). Guidance about the registration process will be provided as part of the Global Pharma/Biotech Pass purchase.
12. Registration of an attendee using the Global Pharma/Biotech Pass must be completed no less than 8 weeks prior to Day 1* of the conference. Registration using the Global Pharma/Biotech Pass within 8 weeks of the start of the conference will be at the discretion of GCSG and on a space available basis.
13. If a company holding one or more active Global Pharma/Biotech Passes is acquired by a company also holding one or more active Global Pharma/Biotech Passes, the acquiring company will own the total of the Global Pharma/Biotech Passes (even if the total adds up to more than the limit of 5 passes per company). No additional purchases of Global Pharma/Biotech Passes can be made until fewer than five active passes remain.
14. Any additional conference specific add-on costs (i.e. Boot Camps and GCSG Night Out Guest Pass) are NOT included in the price paid for the Global Pharm/Biotech Pass. Selecting these add-on options during the conference registration process will require payment of the applicable fee/s.

*Day 1 of the conference is defined as the first day that on-site check-in/registration is available.
